## PORT OF UDDEVALLA

58 deg. 21' N – 11 deg. 55' E  
Skagerrak, Swedish Westcoast

### Entrance

Two channels lead from seaward to the entrance at Sunningesund, which is dredged to 13 m (42.5') and marked on both sides by buoys and lights. Leading lights lead through Byfjorden to the port.

The S channel leads from Marstrand 36 miles NE between the islands Tjoern and Orust and the mainland to Sunningesund. Max. sailing draft in the fairway is 11.0 m (36') and max. air draft 43 m. (141'). The N channel is suitable for ships with max. draft of 5 m (16.4') and a length not exceeding 90 m (294'), air draft 26,5 m. The N channel is very crooked and the tidal stream in the narrows can attain a rate of 3.5 knots.

### Ice

Uddevalla harbour is kept open all year around.

### Time

UTC plus 1 hour in winter. UTC plus 2 hours in summer.

### VHF

Channels 10,16 (calling) and 14 (working).

### Pilotage

S channel via Marstrand pilot:

For dry cargo vessels with a LOA >90 m, width 16 m.

For tankers LOA >80 m, width 15 m.

N channel via Lysekil Pilot.

For dry cargo vessels and tankers LOA >70, width 14, draft 4,5 m.

VHF Channel 16 and 10.

Pilot boards vessel 1.5 miles S of Hatteberget light tower (57 51',05 N 11 26'.3 E) or 1 mile W of Skallen light tower. Distance from pilot station to the port is 40 nm.

For ordering pilot: 5 hrs notice.

### Restrictions in fairway

Max LOA during dark hours; 200 meters.

Max sailing draft 11 meters.

Max air draft 43 meters (two bridges).

**ETA requirements**

Crew list must be given to the Agent not less than 24 hrs before ETA.

All dangerous cargo on board must be reported to the Port not less than 24 hrs before ETA according to IMO regulations. (Class, un-number, quantity, stowage, etc).

ISPS-documents and Waste Declaration to the agent not less than 24 hrs before ETA.

**Anchorage**

In Byfjorden N and S of the fairway. Depths from 40 m and clay-bottom.

**Port restrictions**

Max. LOA for Bado quay is 190 meters.

**Tidal restrictions;** one foot.

**Density**

1.005 – 1.020.

Tugs from 3400 HP and stronger.

Destruction Declaration to be given to receivers stating quantity, type and kind of emulsion used. Delivery only within working hours (07.00 hrs – 16.00 hrs).
